In the absence of reasons of absence from the event, the organizer will ask the GKSS to give a penalty on the player. Registration fee will be refunded the full amount in case of no acceptance by the Organiser and Race in the event of an appeal. The organizer may request to buy 50% of the players who submit a written justification endorsed by the parent club that force majeure will not be able start in the Rally.

board at Rally Office. The penalty for late entry at the checkpoint to enter the car park of pre-closed in relation to the published time schedule will be 300 PLN. All crew must be present in the chair. 16:30 Closed Park (Before Start) to participate in the opening rally.

### **8.4. Starting procedure (SS):**

At each Start there will be 2-digit starting devise with 2 green lights, coupled with a photocell.

Display sequence: 30, 15, 10, 5, 4, 3, 2, 1, green light.

The green light stays on for 20 sec.

SS time control accuracy is 1/10 sec.

### **8.5. Service Park:**

Entry of vehicles permitted, bearing an array of service with the start number of the crew that maintains, will be possible at least 30 minutes before the scheduled time of the first crew to enter the park service. The park service can only be a car service for one of the crew.

### **8.6. Reconnaissance Of The Route:**

Not allowed. Any member of a crew present on the route by **03.09.2010 r.** will violate this rule.

### **8.7. Starting numbers:**

The numbers must be fixed on both sides of a car thought all time of the Rally. Penalty for missing numbers to be inflicted by the stewards. The numbers must be visible.

### **8.8. Identification cards:**

The cards, with photos and signatures, must be in a visible place through all time of the Rally.

### **8.9. Transgression cards:**

Transgression cards is obligatory through all time of the Rally.

Traffic violation penalties:

1. first – 10 % buy,
2. second – 50 % buy,
3. third - EXCLUSION of Race.

**9. PROTESTS - APPEAL:**

Protests made according to the procedures of FIA Sporting Code.

Fee: 100% of the Entry Fee (200% - 500% a car disassembly is necessary).

**10. CLASSIFICATION:**

**CLASS CLASSIFICATION** - in the sequence of ranking resultant from the ascending sum of gained points, comprising crews of a specific class.

**GENERAL CLASSIFICATION** – in the sequence of ranking resultant from the ascending sum of gained points.

**SPONSOR TEAMS CLASSIFICATION** – in the sequence resultant from the ascending sum of points gained by best two crews of the sponsor within specific classes.

**11. RESULTS CALCULATION:**

Penalty points – the sum of all penalty points acquired at all stages.

In case of ex equo SS1 (and consecutive SS's, if necessary) result decides.
